Councillor Cynrig E Hughes delivered a prayer and chaired the meeting.

As a result of the delay, the County Council's Senior Buildings Manager had attended the Finance Sub-Committee at the beginning of November to outline the reasons for the delay

Minutes below

Finance Sub-Committee - Late October postponed to 6th November

Geraint Owen -Senior Buildings Manager, Gwynedd Council - was welcomed to the meeting to discuss the delay with the plans to extend Ysgol Y Faenol.

The work is underway but due to the minor changes in the 'school' part of the project it is anticipated that we will not be moving in until Summer 2021 rather than January 2021.

There is no change in the Community part but it is possible despite the fact that the £150K contribution had now gone that there would be an application for a contribution for the second 'partition wall' in the hall, if the Council was keen on its request to have 2 partition walls.

He believed that would be a sum of approximately £10K

Mr Owen was thanked for his presentation and was asked to send a written request to us regarding the £10K contribution

Finance Sub-committee minutes 6th November were distributed. The financial balance sheet showed £55,689.55 in the account as more VAT refunds had been paid in and the bank declared that notice had been received that further credit from HMRC would be paid 15/11/19

The situation is now totally unreasonable despite the fact that the Clerk was now in weekly contact with HMRC.

It was agreed to transfer all repayments from our current account to our Business Deposit Account so that we know exactly how much of our Budget remains. It was confirmed that the total amount is £39,886.19p A 'likely' expenditure spreadsheet before the end of the year (March 2020) was circulated.

That expenditure was estimated at £27,597.00 and that it would show a surplus of £12,289.19 which was about £1,000.00 lower than the balance at the beginning of 2019-20

Salt for 2019-20 and the salt bins that had been ordered were not included nor the price of the bus shelter at Nant y Mount, if the Council agreed to buy one for that site from this year's budget.

Funding

No development regarding the balance sheet of Marie Curie or Llais Ogwan.

An application was received from Dawns i Bawb Finance Sub-committee recommended not supporting this year's application

Application was received from Glasinfryn Singing Group for a contribution towards the purchase of a piano Agreed in principle to support the application but through the Canolfan as the newly established group does not have officers to be able to arrange a balance sheet themselves.

Recommend that all payments are made

Data Protection Policy Reviewed a) the Public b) Members and Staff as well as Social Media Policy

Recommend that the Full Council readopts them Risk Assessment Cllr L A James would present a table in Full Council

In accordance with the above, the policies in question were readopted and signed

Cllr L A James submitted the **Risk Register** outlining the risk – initial size of risk – measures to Control the risk – and the residual score

The request to donate £10K towards securing the second wall to split the Hall in the new Canolfan was discussed

Cllr D Jones-Morris proposed and Cllr D W Jones seconded that we support the application **Agreed unanimously**

Concern was expressed by one member that the school hall would no longer be extended to enable the pupils to be able to worship together.

The Council was asked to consider contributing more towards the scheme to enable that to happen. Considerable discussion took place, before the Chair drew the discussion to a close and asked the Clerk to make further enquiries either with our solicitors or Once Voice Wales
