Councillor Cynrig E Hughes delivered a prayer and chaired the meeting.

Code of Conduct

Everyone was reminded of our code of conduct and the need to declare an interest on the appropriate form if necessary.

Co-opting process to Faenol ward

Call for election period has now come to an end and Notice to Co-opt has been given since 8th July. That period comes to an end on 20th July.

One name had been received but a further enquiry had been made.

It was agreed:

That should no other name come forward the process would come to an end on 20th July.

Should further names be received, then invite them to a meeting on Wednesday 31st July since there would not be a meeting of the Finance Sub-committee that evening but on the 28th of August.

The minutes were accepted as a correct record, as proposed by Cllr J Griffiths and seconded by Cllr B Jones

Matters arising from the minutes

Penrhos Parking

Cllr M Baines reported that nothing had been resolved and that very little response had been received from Ysbyty Gwynedd and Natural Resources Wales

She added that she had contacted CCG regarding the Pen y ffridd development and was given to understand that they are proposing to build 30 houses, 60% of which would be offered on the open market and 40% would be for rent

They do not intend to expand any further but local residents are very concerned about the increase in traffic

<u>Finance Sub-committee</u> - Minutes of the Finance Sub-committee held on 26th June were circulated. At the time, these showed a deficit of £150 but the reason for it had been discovered since one Councillor had still not presented an expenses cheque

No applications for funding and too soon for any response from the external auditors.

Still awaiting repayment for Cemetery gate from Aviva

FATCA Tax form for HSBC had been completed and signed. The form needs to be returned by 22nd August Terms of the Clerk

The Finance Sub-committee had met before the full council meeting this evening to discuss terms for the Clerk

It was recommended that his salary point be increased from Point 20 to Point 23 and his weekly hours be increased from 10 to 12, to be backdated to the beginning of April this year

The recommendation was unanimously approved and the Clerk was thanked for his dedication

<u>Planning Applications</u> No application at the time Agenda was sent but Treborth Uchaf Application C19/0643/25/LL for Demolition of existing extension and erection of two storey extension in its place has just arrived and Councillors' response required

Discussion re email received by the Clerk from Gwynedd Enforcement regarding an enquiry about Bryn Hywel Rhyd y Groes and Coed Faenol Site at the bottom of Allt Faenol.

Serious concerns were expressed regarding the negative responses
