2. Apologies:

- 5. Matters arising from the minutes
 - a. Glan Menai Path No resolution has been forthcoming and the signs are still up
 - b. New Logo Cllr L A James has been in touch but there were no details to share as further discussions were needed Cllr L A James to continue discussions
 - c. Glasinfryn Septic Tank Clerk had had a meeting on site with Mr W Font before Christmas and the expert had come back to state that there was a public sewer pipe on the track leading up to the car park

He suggested that we ask a builder to investigate the possibility of a connection to that pipe that would do away completely with the septic tank.

The Clerk had asked two contractors whom he had identified as capable of undertaking the work in question.

- 6. Financial Matters
 - a. No meeting of the Finance Sub-committee had been held during December so we could only share a financial balance sheet showing our current financial position as £33,995.17 in the Current account and £25,037.19 in the Deposit account
 - b. Glasinfryn Centre No further development regarding the transfer of the title to the Council's name
 - c. New Centre New restrictions have meant that the work is running a little behind schedule due to failure to obtain goods such as windows etc.
 - i. Electrical aspects agreed
 - ii. Kitchen equipment agreed
 - iii. Flooring material agreed
 - iv. BT to reconnect line to the Existing Centre at Wynne's cost but this will make it easier to transfer the line to the New Centre once ready
