2. Apologies:

- Election of Chairman Cllr D W Jones was elected to the chair and he offered the prayer before welcoming all present and wishing a speedy recovery to Cllr J Pierce who had not been well of late
- 4. Declaration of interest

It was explained that should anyone need to declare an interest it would have to be done verbally so that the Clerk could record it – There was no declaration

- 5. To receive minutes of 10th September 2020 The minutes were received as correct
 - Cllr E Jones proposed and Cllr D Jones-Morris seconded
- 6. Matters arising from the minutes
 - a. Cllr E Jones explained that signs indicating a footpath to National Trust Land at Glan Menai continued to cause concerns for walkers but the matter had been referred to the rights of way department
 - b. Parc y Mount Bus Shelter was still unresolved as it had not been possible to have a site visit and agree a location that would be acceptable to the objector
 - c. Redrow Estate Cllr M Baines reported that the roads were going to have work done on them in a week's time. Residents still unhappy/dissatisfied with the value for money from the Trinity Company. Report back again in a month

 Cllr M Baines New Application, Dental Surgery at Parc Menai
 For information, it was reported that Gwynedd Council had refused to grant a planning application for a Dental Surgery on Parc Menai.
 A new application would be submitted.

She requested support for that application.

Cllr M Lynch Sale of Vaynol Arms Pub and the effort of local residents to look at the possibility of purchasing it

It was reported that two meetings had been held since our last meeting – One with the area's Regeneration Officer Dafydd Einion Jones present to talk about examples of this kind of project. The local group is a small but very enthusiastic group – their biggest concern is that someone will buy it and change its use but it was explained that such a move would require the planning department's approval and there would then be an opportunity to oppose the application. It was agreed to hold a survey on the Council's website to seek further views among local residents on their ideas/opinions

The meeting concluded at 8.45
