Is there enough local support and would that local support be unanimous? It is possible to justify substantial expenditure when there is already a Village Hall in Rhiwlas and a Community Centre in Glasinfryn – both locations close to Pentir It was agreed to wait at present as the local pub is still not open and that might solve some community space issues

Empty seats following the May 2022 Election

As there were 3 vacant seats to be filled, it was explained that this had to be advertised publicly and that we would need to wait to see if there was a response. Former Cllr D W Jones had sent his form in, but he had not completed the second part - He had declared

his desire to come back for another season but he would have to go through the process again

Cllr M Baines Japanese knotweed at Pentir cemetery

The Cllr raised that concern had been expressed by one of the constituents regarding this plant in the Church Cemetery fearing that it would seep into their fields

The Clerk has already raised the matter with the former minister, but nothing has been done and the problem is still there

The Clerk to contact the diocese again as there is no longer a Rector in Pentir
