## b. Purchase land at Penrhosgarnedd

Cllr D Jones-Morris reported that he had found that a piece of land had come on the market from a Local Company that may be suitable for the expansion of our green spaces. He did not think it would be suitable to rent as allotments but it would be possible to create a community garden there

There was considerable discussion before approving that the Clerk contact the Sales Company to declare and register an 'interest' which would cost nothing.

The Clerk to also contact our Solicitors to obtain Legal Advice in case there are legal conditions which would prevent us from developing it and/or accessing the land

Cllr D Jones Morris to contact a professional valuer to find out what would be a fair price for such land before the Auction that will be held in mid August

Once that is done call a special virtual meeting of the Full Council to find out if the whole Council approves

### c. Ysgol y Faenol

Now that the builders have left and the school has moved out of the Centre it is important that we consider what direction Pentir Council is going to take to manage the new Centre

The 'old lease' for the existing centre stated that it was necessary to establish a 'management committee' to run the centre with one Councillor representing the Council on that Committee and the remainder either elected, Co-opted and/or representing users

The new lease will no longer refer to a management committee and by this point if it wasn't for a number of Councillors there would be no Committee either

Due to the pandemic very little use has been made of the Centre and it may be better for the Council to try to market it and then establish a 'User Committee' if that's what they wish As the current management Committee has Charitable status the Charity Commission's statutory rules must be followed

It was agreed to arrange a meeting between the Management Committee and representatives from the Council and to avoid holding two meeting it was proposed that it be held an hour before the Full Council in September.

That meeting will commence at 6.00pm on Thursday 8th September at Canolfan Penrhos

## c Gamlins

Two days before the Full Council there was a meeting between the Attorneys, the Clerk and Cllr L A James to discuss the lease of the new centre and the completion of the sewerage works at Glasinfryn

An email was shared from Gwynedd Council which eased several concerns regarding the situation between the Church and Gwynedd **The e-mail has since been shared** It was discussed to send a letter to the owner of a house that had connected his house to the septic tank system. They will be warned that the tank will be decommissioned at the

end of January 2023 and to make different arrangements for their sewerage before then

## 11. Also for discussion

Risk Register/Policy Cllr L A James shared the modified Risk register.

It has highlighted the issues that need to be addressed and it was agreed to meet at the end of August to discuss the issues that need to be addressed.
