## Minutes of the Finance Sub-Committee meeting held at Penrhos Community Centre at 7.00pm on Wednesday Evening 28th October 2022

2. Apologies Cllr L A James; Cllr J Lewis
3. Code of Conduct It was explained that the procedure for declaring an interest is now easier as we are meeting face to face, and forms are available from the Clerk  
No declaration of interest
4. Minutes of the last Meeting 28-09-2022  
It was proposed that minutes were accurate by Cllr I Ellis and seconded by Cllr D Jones-Morris
5. Matters arising from the minutes  
It was noted that it was not possible to receive more than one machine through the Defibs Unllais/Welsh Gov scheme and that it would be expected for them to be for a young community group if possible **Clerk to check with Bangor Saints FC as a machine has been installed by the Penrhosgarnedd FC Youths changing rooms**  
An e-mail from Scottish Power was read, apologising for its additional costs and saying there would be a £20.00 credit on our next invoice  
There were no responses from the Sub-Groups  
Penrhos Road shelters continue to cause concern **Clerk to contact Gwynedd again**  
Caerhun playing field Although quotes had been received it was felt that the prices weren't for the same things. Expecting a more recent quotation from one Company that gave us a price in 2020
6. Financial Report  
Copies of the balance sheet were shared, showing £46,547.66 in the Current Account and £45,064.37 in the Deposit Account
7. External audit  
Final reports for 2019-20 and 2020-21 finally returned and no issues identified  
Report for 2021-22 not received but Clerk has made enquiries
8. Risk Register/Policy  
Some of the risks identified as requiring attention were discussed e.g. the playing field and shelters. **Clerk to make further enquiries**  
The need to try to sort out the new centre's issues was also identified. This could be done by persuading Cyngor Gwynedd and the Church to come together to put a lease in place - if possible - as well as reaching an agreement on the way forward to manage the new centre. A meeting needs to be arranged between the current Management Committee and the Council Training Plan  
It was noted that Community Councils are now required to provide a training plan and assess the training needs of Clerks and Councillors **Clerk to organise this**
