Chair declared that she was a Trustee on the Management Committee of the Ganolfan. It
was also confirmed that she was there as a representative of the Council and therefore she did not need to declare an interest
4. Minutes of the last Meeting 29-05-2024
The minutes were accepted as a true record, as proposed by Cllr I Ellis and seconded by Cllr D Jones-Morris

- d) Penrhos Active Route Update (Coed y Maes junction) (Ysbyty Gwynedd crossroads)
The Councillor reported that he had contacted the Cyngor Gwynedd Traffic Officer regarding the two issues of concern to himself and his neighbours due to the fact that the turning out of Coed y Maes was dangerous and that the Crossroads was on the original plans but had now been removed from the plans because one person had complained
Awaiting a response from the Officer
- e) Feedback from the Canolfan Penrhos Car Park site meeting with Gwynedd Council officers.
A Meeting had been held between himself and Officers from Gwynedd regarding the planning of the Car Park. Waste aggregates will be placed and rolled/hardened over the school holidays and a safe path marked towards the back of the school and through a pedestrian gate which will be placed on the boundary between the car park and the School Yard
A sign will be erected stating when parents can use the car park for dropping off and picking up their children
Parking places will be painted and re-painted every 6 weeks or as required
- f) Penrhosgarnedd Christmas lights
Council keen to confirm the locations of the lamps upon which the lights will be placed and will undertake a walking exercise to note the lamp numbers in order to facilitate the work for the Street Lighting Department
