### Minutes of a meeting of the Full Council held on Thursday 12th September 2024 in Penrhosgarnedd Community Centre at 7.00

#### 1. Presennol: /Present

Cllr I Ellis Chair, Cllr J Pierce; Cllr L A James; Cllr A Joyce; Cllr J Griffiths; Cllr C W Owen; Cllr D Jones-Morris; Cllr B Jones.

Also Sioned Jones Translator, Iwan Ap Trefor Transport Officer, Gwynedd Council and the Clerk.

### 3. Address by Mr Iwan Ap Trefor, Transport Officer, Gwynedd Council

The Chair welcomed Iwan Ap Trefor to the meeting before Iwan commenced the discussion by emphasising that he was keen to have a discussion rather than to give a presentation, and to hear the opinion of the Councillors and thus, those of the community.

The entire scheme was discussed, bearing in mind that only a small part of the present scheme is within the Pentir area.

Concern was expressed that cars were being parked on the path as well as cycling continuing on the road and it was inquired whether there was a real need for the narrow green area between the Path and Penrhos Road.

It was explained that the green area was included in the plan as somewhere for surface water to drain into the earth rather than flow onto the main road, but that this was being reconsidered especially in designing aspects 2 and 3 of the major scheme.

### Location of the Crossing has been controversial

It was suggested that having a crossing by the Ysbyty Gwynedd roundabout and another close to the Coed y Maes and Penrhos Road junction would be more acceptable than having one half way between the two locations - the Council would consider this.

The Chair thanked Iwan for his time.

Iwan Ap Trefor left and Cllr D Jones-Morris apologised that he also had to leave the meeting.

### 4. Datgan buddiant / Declaration of interest

Cllr A Joyce and Cllr L A James declared that they were trustees of Penrhosgarnedd Community Centre.

### 5. Derbyn cofnodion / Accept Minutes 25ain o Orffennaf / July 2024

Cllr Joyce referred to the fact that the minutes did not name him expressing his dissatisfaction regarding accepting the July minutes as being correct, and for the minutes to be amended. The Chair explained the minutes stated that the minutes had been accepted as correct by the majority, with no-one being named. The Clerk explained that minutes needed to be accepted, with any errors in terms of accuracy being noted in the minutes of the following month. Accepted as a correct record, as proposed by Cllr L A James and seconded by Cllr J Pierce. Accepted by 6 members with 1 abstention.

  - Shared Licence and Car Park Update on the Centre / Ysgol y Faenol The parking system is working well to date from the point of view of the School and ourselves. We need to keep track of the marking of parking spaces and the path and how the winter months will stand up to the weather. Are lights needed? If there is space, where will the connection be and who is responsible for the cost.

The County Council needs to be kept under pressure to ask whether there is any development from the discussions between them and the Church.

Cllr B Jones	Refuse around Ysbyty Gwynedd and the area in general Concern was expressed regarding the general condition of the Penrhos area in terms of refuse but more specifically within the curtilage of Ysbyty Gwynedd. Clerk to contact Paul Andrews, Cllr L A James to send a job title etc.
Cllr I Ellis	Christmas lights Gwynedd has confirmed the need to select lamps that do not have a camera on them as Councillors have noticed that two of the lamp posts in question have now had a camera installed on them. Need to select and order lights to enable installation and electrical work to be carried out at the same time
Cllr J Griffiths	Developments on the field in Caerhun – Clerk has already contacted the planning department – further pressure needed as time is marching on. Glasinfryn Centre roof leaking again Clerk has contacted a Contractor Caerhun Noticeboard – broken hinge Clerk has contacted a Contractor Caerhun Glasinfryn Footpaths Clerk has contacted a Contractor who is running late due to the wet weather Parking on the bridge over the A55 Clerk has contacted the Police – Not illegal unless there is a ban and/or they are causing an obstruction
Clir A Joyce	<b>Risk Register</b> It was noted that his comment had been passed on to the Finance Sub-committee but that the Committee had not met during August It was suggested that he send any recommendation/adjustment/ addition he was keen for the Finance Sub-committee to consider
