# **Minutes of Pentir Community Council**

# Virtual Meeting of the Finance Sub-committee at 6.30pm on Wednesday evening, 27<sup>th</sup> October 2021

- 3. Discussion with Gwynedd Regeneration Officer, Consultation on the Regeneration Framework Lle ni 2035 and the options for taking responsibility for Gwynedd Council playing fields

Regeneration Framework consultation

DEJ outlined the background to the consultation along with a definition of the 'Area' such as the City of Bangor, Pentir Ward and Felinheli Ward. He explained that there would be 3 stages to the process and this step was only part 1 to find out the views of the communities before moving to Part 2 which would identify schemes and look at ways to fund them and then act on those schemes

- There has been considerable discussion on ways to improve the image of the area in general especially Bangor High Street
- > To look at whether empty buildings/houses could be adapted rather than building on the edges on greenfield sites
- A need to establish a central health centre and better support Ysbyty Gwynedd
- A need to attract Work to the area. Parc Bryn Cegin undeveloped and many vacant spaces on Parc Menai and Llandegai Industrial Estate
- > Transport problems are a major problem especially on Penrhos Road
  - o with parking problems as a result.
- Lack of suitable places to cycle and walk and a need for them

It appeared that there were more concerns than support but the 'Welsh language' element in the Pentir/Penrhos area was praised and the desire for that to continue despite threats from the 'Buy to let' aspect of housing

Options for taking responsibility for Gwynedd Council's playing fields

A letter had been received before the Pandemic inviting Community Councils to assume responsibility for playing fields which at that time were managed by Gwynedd Council. Whilst Pentir Council had expressed support, in principle, for the idea, there had been very little development since then.

DEJ suggested that we contact Llion Foulkes at Gwynedd Council again via e-mail to inquire about options for consideration and to copy him into the e-mail
