### 4. Minutes of the last Meeting 24-04-2024

#### 5. Matters arising from the minutes

It was confirmed that a meeting had been held on 9th May between Gamlins Solicitors and a delegation from the Council to discuss the terms/conditions Gwynedd Council wished Pentir Council to accept.

Amendments to those conditions had been proposed and by now those amendments had been accepted by Gwynedd Council

It seems that things are now moving forward quickly therefore so that it is possible for Gwynedd Council to commence the work of adapting the car park as soon as possible, the Clerk was asked to confirm acceptance of the terms in the Chair's name adding that

- a sign is being erected in the name of Gwynedd Council and Pentir Council in a prominent location noting at what times the permit is operational
- There is an opportunity to revisit the situation in September before the School reopens Once these terms are a binding legal offer they will need to be signed and confirmed with the Management Committee

Flower Boxes - re-planting Costs + Labour

2 flower boxes at the entrance to Ysbyty Gwynedd had been refurbished but the contractor reported that everything from plants and compost and labour amounted to costs of around £175 - £190 per box

2 other boxes in Caerhun were in desperate need of attention this year, quite quickly due to a shortage of plants at this time of year

Recommend that the contractor carries on

Penrhos Street Lamps and Christmas Lights

It was discussed that not clustering too many lights around the entrance to Ysbyty Gwynedd would benefit the wider community and therefore to consider installing them every other street lamp, or every three street lamps would be more equitable

Clerk to inquire with Gwynedd Council for a map showing the lamps from Capel Graig to the boundary of Pentir and Bangor City

For information the Clerk reported that he attended the Annual Meeting of Glasinfryn Centre and that they were looking for a Chair but the Treasurer had agreed to undertake the post on a temporary basis

A presentation was given by Cllr Dafydd Meurig on behalf of Ynni Ogwen proposing the Heuldro scheme which might benefit the Centre to save energy costs

The centre to consider as well as Ynni Ogwen to see if the initiative would be value for money All that would be needed from Pentir Council would be permission to use the roof
