#### 7. Risk Register/Policies

**Financial Regulations** While Cllr L A James had reviewed our current Regulations, a template of Regulations had been received from One Voice Wales. It was agreed to amend them for Pentir Council ready for submission and adoption in Full Council

## 8. Clerk's Matters

Agree on the material of the chapel floor - Clerk still awaiting examples from the Company Co-option panel **6 names received for co-option** 

It was agreed to establish a panel of 3 and the Clerk to 'interview' informally for a conversation and questioning

It was agreed that the Clerk, the Chair and the vice-chair, and the Chair of the Finance Committee should be on the panel

## Clerk to contact the individuals and arrange a date and time for them

**External Audit** The auditors had contacted the Clerk to enquire about items that had already been posted to their Office as well as the items that had been sent electronically

**Lightsource** - community funding. The Company has now been granted planning permission and is keen to know if the Council is going to claim its share of community benefit funding. Recommend to the Full Council that we do and try to identify projects that could benefit

**Salary Scales 2024-25** The Clerk had received correspondence regarding an increase in the National Salary Scale with back pay to April 2024 for clerks

## Clerk to pass on the information to the Accountants responsible for the payroll

It was also proposed that the Council undertakes to review either the Clerk's salary scale and/or hours

#### **Christmas Decorations/Lights**

Following ordering and receipt of decorations for Penrhos Road, the Gwynedd Street Lighting Section came back to us to report that it was not possible to install them on the lamp bases on Penrhos Road, due to their size

Following co-operation between the Street Lighting department and ourselves a process is in place to send the equipment back and to receive 12 smaller decorations suitable for installation
