Minutes of a meeting of the Full Council, Thursday, 9 January 2025 In Penrhosgarnedd Community Centre at 7.00

3. Croeso / Welcome

The Chairman welcomed all attendees to the meeting and wished everyone a Happy New Year. He went on to state that our Christmas decorations had been gratefully welcomed by a number of constituents, but that they had now been taken down – a project which we can certainly extend.

He officially welcomed the two new Councillors and invited them to introduce themselves and say a few words about their interests.

Cllr Megan Jones began by stating that she has now lived in Caerhun for 5 years – qualified as a solicitor but now works for the North Wales Wildlife Trust – she surprised everyone by stating that she is a Welsh learner.

Cllr George Owen – now retired – originally from Sling but has lived in Penrhosgarnedd since 1969 – spent his life in construction.

Cllr L A James and Cllr A Joyce declared that they were trustees of Penrhos Centre.

5. Derbyn cofnodion / Accept Minutes 21 Tachwedd / November 2024

Cllr A Joyce revealed that he had not accused the Council of wrongdoing but that he had to 'consider' that. It was noted once again that the minutes could not be amended, but rather, his statement in the minutes taken on the evening could be noted.

Whilst it was understood that there was now a lack of funding, the need for a second crossing near the Shop was emphasised.
