

# Minutes of the Full Council meeting held on Thursday 25<sup>th</sup> July 2024 in Glasinfryn Community Centre at 7.00 pm

# 1. Presennol /Present

Cllr I Ellis (Chair); Cllr L A James; Cllr E Roberts; Cllr J Pierce; Cllr A Joyce; Cllr D Jones-Morris; Cllr C Owen (Clerk); and Sioned Jones (Translator)

# 2. Ymddiheuriadau/ Apologies

Cllr J Griffiths; Cllr B Jones

Before commencing the meeting, the members were thanked for being willing to change the date of the meeting because of the Clerk's hospital treatment on the 11th of the month. He was welcomed to the meeting tonight and wished a full recovery

# 3. Datgan buddiant / Declaration of interest

Cllr A Joyce and Cllr L A James declared that they were trustees of Penrhosgarnedd Community Centre

### 4. Materion yn codi o'r cofnodion / Matters arising

It was explained that a request had been received by Cefin Roberts, asking whether it would be possible for the group he had represented before us in June, 'active Pentir actif', to use the items on the Historical Panel in Pentir, or were they copyrighted.

Clerk to enquire, but no objection. We discussed the need for a letter from the Council as a letter of support if the building were to be put on the market.

Cllr A Joyce asked why his comments regarding the proposed licence for the Penrhosgarnedd Centre car park had not been recorded.

It was explained that he was given a verbal explanation in the June meeting and that the explanation remains the same 'As he had declared an interest – trustee/treasurer of the centre – and had left the room when the Licence was discussed in the May meeting, it was not appropriate for him to comment on the issue as his interest is biased

It was noted that the Chair had visited Cllr Menna Baines, who resigned from her role as a Community Councillor, to ask whether she would reconsider. 'She couldn't be swayed regarding her decision, but she was thanked for her contribution and was told that she is welcome to come to our meetings as an observer in her role as a Local Member

The Chair was thanked for his efforts

# ii. Cofnodion cyfarfod IBC / Minutes of FSC 26/06/2024

The package included the June Minutes that had been accepted as accurate minutes the previous evening, 24/07/24.



It was noted that, following inspection, 2 defib machines had to be reported because of faults

New batteries had been installed in the machine in Treborth, and the one in Caerhun had been temporarily replaced and sent off to be repaired It was suggested to the Clerk that many councillors were happy to conduct the inspections rather than him having to go around each one himself

# **FSC Meeting 24/07/24**

A meeting was held last night specifically to discuss the policies that need to be reviewed/modified if necessary, and adopted for 2024-25 **See under item 8 Policies** 

It was recommended that the payments needing attention be paid, and this was confirmed

# 7. Cynllunio / Planning

C24/0532/25/LL Lleoliad / Location: Land at Pentir Substation, Pentir, Bangor, LL57 4ED Bwriad / Proposal: Proposed Energy Storage Facility, accompanying access, landscaping, infrastructure, supporting equipment, with grid connection import and export capacity of 57MWac. **No Objection** 

C24/0511/25/DT Lleoliad / Location: Mon Awelon, Treborth, Bangor, Gwynedd, LL57 2NJ Bwriad / Proposal: Proposed one-storey extension

This case was discussed in detail because an objector had contacted the Clerk expressing concern for their property. It was agreed that this would be a civil matter and that there were no obvious reasons that would contradict planning policies. Therefore, the committee had to declare **No further comment** 

C24/0529/18/CR Fferm Ty'n Llwyn Lôn Ty'n Llwyn, Pentir, Bangor, Gwynedd, LL57 4DY Converting an outbuilding into a holiday unit This application was also discussed before failing to reach a decision to support or object

Although it is easier to support the conversion of buildings into holiday units rather than houses, it was questioned whether allowing this application from an individual who doesn't farm would push the holiday unit quota for the area – possibly resulting in having to refuse future applications from farmers, who are incentivised to diversify, because the quota has been reached

# 8. Materion y Clerc / Topics from the Clerk

- Electing a Vice Chair It was agreed that the election would be postponed until September because some members had apologised that they were not in attendance, and as we now have 3 empty seats
- Policies It was confirmed last night that the Standing Orders, Code of Conduct, Language Policy and Financial Rules had already been translated but needed reviewing. The rest of our policies need to be reviewed and translated, and Health and Safety and Complaints Policies need to be created from scratch FSC to look through them before presenting them to be adopted by the Full Council



It was noted that the committee needs to budget for translating the website, which has historically been Welsh-only. This may need to be undertaken over a period of more than a year

#### Rhyddid Gwybodaeth / FOI

This matter has not concluded but there has been a request to establish someone to conduct an internal review of how the Council has responded to this request thus far It was agreed that the Chair would undertake this task alongside ClIr C W Owen

The Pentir Council Insurance now includes the Penrhosgarnedd Centre building in line with the legal instruction we received from our solicitor, and the unwillingness of the committee to include the names of Cyngor Pentir and Cyngor Gwynedd in their insurance policy

Cllr Joyce expressed that he believed the Council had spent too much on insurance
